TERMS AND CONDITIONS OF REGISTRATION

- 1. Registration

- 2. Terms
 - 2.1 If you breach these or any of our other terms and conditions, DLG reserves the right to close your account; if we do so, we may close all accounts you have open in your name.

- 3. Administration
 - 3.1 You can update your profile (including your account and marketing preferences) by contacting DLG Naturals via the "Contact Us" option on your Login-Home page.
 - 3.2 DLG may, with or without notice, change your password at any time.
- 4. Data
 - 4.1 At no time will DLG give to any third party, for whatever reason, your personal information, except as follows:

- (4) We never sell personal information, or pass it to third parties for marketing purposes, without your permission.
- 4.2 Additional information may be requested from you by DLG regarding your profile, business, products, and services, as these relate to DLG products and services and access to the web site, at any time. This information may be optional or required. If required, and the information not submitted to DLG, your account may be subject to closure.

 - 5.3 These terms are not intended to create and shall not create any rights, entitlements, claims or benefits enforceable by any third party.
 - 5.4 These terms and/or your use of the website shall be governed by and construed in accordance with U.S. law, and the State of Wisconsin shall have exclusive jurisdiction over any dispute which may arise.
